### LIBERTY COMMON SCHOOL CONTRACT PURCHASED SERVICES PROVIDED TO LIBERTY COMMON SCHOOL BY POUFRE SCHOOL DISTRICT

1. Payroll Services  
No services provided to Liberty Common School by Poudre School District effective 9/1/2001.
2. Employee Benefits  
No services provided to Liberty Common School by Poudre School District effective 9/1/2001.
3. Budget Services  
No services provided to Liberty Common School by Poudre School District.  
  
Liberty Common School will provide to Poudre School District the annual budget adopted by their Board. The budget shall be in the state required budget format.
4. Financial Services  
No services provided to Liberty Common School by Poudre School District.  
  
Liberty Common School will provide a monthly journal entry and financial statements to the Poudre School District Finance Department in the Colorado Department of Education's school required chart of accounts format.
5. Personnel Services  
No services provided to Liberty Common School by Poudre School District.  
  
Liberty Common School will provide state-required data to Poudre School District Personnel Department for electronic reporting to the Colorado Department of Education.
6. Information Systems Services  
No Information Systems, and Computer Network services will be provided to Liberty Common School by Poudre School District.  
  
Current Internet services provided by PSD will be continued through 6/30/2002 at current per pupil costs.

Student data for required student counts and other mandated Colorado Department of Education reports shall be provided to Poudre School District Information Systems Services prior to the due date by Liberty Common School.

7. Records Services

No services provided to Liberty Common School by Poudre School District. The School District shall have reasonable access to all records of the School in the same manner as they would have access to the records of any other public school in the School District.

8. Purchasing/Delivery

No services provided to Liberty Common School by Poudre School District.

Liberty Common School may purchase items from the Poudre School District warehouse with the standard markup charged to other Poudre School District schools.

9. Media Services

Poudre School District will broadcast on their public television channel up to 2 hours per month, materials chosen by Liberty Common School. Such material must receive prior approval by the District Video Education Specialist in accordance with Board of Education approved programming policies and procedures. The District reserves the right to determine the scheduling of such programs.

10. Food Services

No services provided to Liberty Common School by Poudre School District.

Liberty Common School will report free and reduced lunch student counts to Poudre School District Food Services Department for required Colorado Department of Education reports.

11. Facilities/Grounds/Building/Telephone Maintenance Services

No Facilities, Grounds, Building, and Telephone maintenance services will be provided to Liberty Common School by Poudre School District.

12. Bus Transportation

No services provided except bus transportation for student field trips may be provided by Poudre School District at the standard rate charged other Poudre School District schools and on a bus-available basis.

13. **Property/Risk Insurance**  
No Property, Persons, Workers' Compensation, Liability or other risk insurance and services will be provided to Liberty Common School by Poudre School District.
14. **Athletics**  
No services provided to Liberty Common School by Poudre School District except as provided for in Section 11 of this contract.
15. **Curriculum Assessment**  
No services provided to Liberty Common School by Poudre School District.
16. **Employee Training/Development**  
No services provided to Liberty Common School by Poudre School District.
17. **Grant Application**  
No services provided to Liberty Common School by Poudre School District.
18. **Security and Safety**  
No school security and safety services will be provided to Liberty Common School by Poudre School District.
19. **Special Education**  
Per Section 9 of this Contract, Liberty Common School may contract with the School District to provide special education and related services. The amount to be paid by the charter school in purchasing any district service pursuant to this paragraph (19) shall be the actual costs incurred by the School District in providing the service to Liberty Common School.
